## **SECTION 6 - ACCIDENTAL RELEASE MEASURES**

**6.1 Personal precautions, protective equipment and emergency procedures:** Do not take action without suitable protective clothing - see section 8 of SDS. Evacuate personnel to safe areas. Ensure adequate ventilation. Avoid breathing vapors, mist, dust or gas.

**7.2 Conditions for safe storage, including any incompatibilities:** Store in cool, well-ventilated area. Keep away from direct sunlight. Keep container tightly sealed until ready for use. Store desiccated at -20 °C. Store in a dry place. Protect from moisture.
