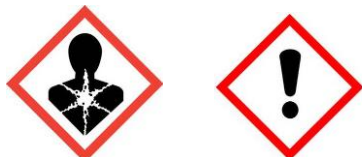

SECTION 6 - ACCIDENTAL RELEASE MEASURES
