

Official Rules: \$500 MIDSCI Product Credit Giveaway

The **\$500 MIDSCI Product Credit Giveaway** (the "Giveaway") is open to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Employees of **MIDSCI** ("Sponsor"), its affiliates, subsidiaries, advertising agencies, and the immediate family members (spouse, parents, siblings, and children) or household members of such employees are not eligible.

- **Limit:** One (1) entry per person, per email address, and per institution for the duration of the Giveaway Period.
- **Duplicate Entries:** Multiple entries from the same person or institution will be void. All entries become the property of the Sponsor.

6. Winner Selection & Notification

On or about **May 1, 2026**, the Sponsor will select one (1) potential winner via a random automated selection tool from all eligible entries received.

- **Notification:** The potential winner will be notified via email or telephone on or about **May 10, 2026**.
- **Claiming Prize:** The potential winner must respond and submit a signed **Declaration of Compliance** within five (5) days of notification.
