

Official Rules: Upgrade Your Lab - The Ultimate Pipettor Giveaway

The contest will run from 05/27/26 – 06/30/26. All [Terms](#) and Official Rules apply.

1. Eligibility

The **Upgrade Your Lab: The Ultimate Pipettor Giveaway** (the "Giveaway") is only open to those who sign up at <https://gleam.io/AhxeT/midsci-giveaway-upgrade-your-lab-the-ultimate-pipettor-giveaway> and are legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry.
